
Flexible. Simple. Charitable.

Giving becomes convenient and personal with a Donor Advised Fund (DAF), which offers a hands-on approach to philanthropy. This fund invests your charitable gift to grow tax-free for future giving. A Donor Advised Fund allows you the opportunity to make contributions to Ave Maria Catholic Church as well as to other Catholic or charitable organizations. Donor Advised Funds are very popular because they are flexible and manageable from one simple account. It's your "Charitable Checkbook".

You can...

- Open DAF with no minimum
- Advise when and where to send distributions
- Spend the fund down to zero or grow for future gifts
- Grant to multiple organizations including Ave Maria Catholic Church and the Ave Maria Parish School; the Rhodora J. Donahue Academy
